- h) He/ She must have a No Objection Letter from his/her employer/sponsor in original, duly attested by chamber of commerce and industry in which the sponsor should clearly mention that He/ She is agreeable for the active participation of the candidate in Managing Committee meetings for the tenure and that candidate will be in a position to attend the meetings even at a short notice.
- i) He/ She must produce salary certificate issued by his / her employer and attested by chamber of commerce in the region stating that monthly salary is not less than **SR 8000**.
- j) He/ She should submit a brief description, not exceeding 100 words explaining his/ her plans to ensure better education to the children of Indian community and all-round progress of the school during his/ her tenure.
- k) His/ Her place of work and residence should be within the city limits where the school is situated.
